

Littauer Birthing Center recognized again for higher quality in maternity care

Excellus BlueCross BlueShield has once again recognized the Nathan Littauer Hospital Birthing Center with a Blue Distinction® Center for Maternity Care designation as part of the Blue Distinction Specialty Care program. Blue Distinction Centers are nationally designated hospitals that show expertise in delivering improved patient safety and better health outcomes, based on objective measures that were developed with input from the medical community.

Nearly four million babies are born in the U.S. annually, making childbirth the most common cause of hospitalization, and cesarean sections the most common operating room procedures, according to National Centers for Health Statistics and the Agency for Healthcare Research & Quality (AHRQ). Reducing early elective delivery is an area of focus for the American College of Obstetricians and Gynecologists (ACOG) and the American Academy of Pediatrics (AAP). According to Health Affairs, elective inductions result in more cesarean deliveries and a longer maternal hospitalization. The Blue Distinction Centers for Maternity Care program evaluates hospitals on quality measures for vaginal and cesarean delivery.

Blue Cross and Blue Shield (BCBS) companies across the nation have recognized more than 1,000 hospitals as Blue Distinction Centers for Maternity Care. Hospitals recognized with this designation are assessed using a combination of quality information supplied by hospitals and cost measures derived from BCBS companies' medical claims.

Since 2006, the Blue Distinction Specialty Care program has helped patients find quality specialty care in the areas of bariatric surgery, cancer care, cardiac care, maternity care, knee and hip replacements, spine surgery, and transplants while encouraging healthcare professionals to improve the care they deliver. Research shows that compared to other hospitals, those designated as Blue Distinction Centers demonstrate better quality and improved outcomes for patients.

Saying Goodbye

The Nathan Littauer Family had to recently say goodbye to Doctor David V. Clough. Doctor Clough died peacefully on December 2, surrounded by his loving family.

Doctor Clough and his family came to Gloversville (his wife, Ann Lee's hometown) where he established his

private practice in 1963. In addition to maintaining his private family practice, Doctor Clough served as Nathan Littauer Hospital's chief of medicine, vice chief of staff, and chief of staff. Doctor Clough was involved with the Hamilton County Rural Task Force and established and directed a medical clinic in Wells from 1978 to 1990. He was active in recruiting family practitioners to this area.



Doctor Clough also developed a special area of expertise in the treatment of respiratory illness and was responsible for establishing and operating Littauer's Respiratory Care Department. He was also instrumental in the development of an asthma camp which evolved into Camp SuperStarrs, a summer day camp for children with chronic breathing disorders, cystic fibrosis, and diabetes.

In 1989, Doctor Clough was named Family Physician of the Year by the New York State Academy of Family Physicians. At the time the academy reported, "He has continued to be a caring, dedicated, outstanding family physician who has given his personal and professional life to his community, his colleagues and his students." In 1992, he was also named one of the most influential physicians in New York State.

Following his departure from his private family practice, Doctor Clough served as the medical director of Nathan Littauer Hospital.

Thank you, Doctor Clough, for your service to not only Nathan Littauer Hospital, but our community as a whole.

We will miss you.

Nathan Littauer Hospital proposes primary care clinic in Broadalbin

'It's got the potential for growth; we think it will grow in the next 10 years'

BROADALBIN — Nathan Littauer Hospital wants to build a \$2.1 million medical clinic on Route 29 in Broadalbin. The facility would be the 11th primary care facility for the Gloversville hospital and the first in the rural Fulton County town. The hospital submitted a request Friday to the state Department of Health for a certificate of need. The proposal also must undergo town review. Hospital officials are optimistic about receiving both approvals early enough to break ground in June; if all goes well, they hope to open the doors early next year. "We're thinking a year, first-quarter 2019," said Lawrence E. Kelly, president and CEO of Nathan Littauer Hospital & Nursing Home. "If we can break ground in June, we can have it ready."

He said Littauer was interested in Broadalbin because its population has seen slight growth, and sitting on the Saratoga County border, it may see further growth as development pushes west from Saratoga Springs. Also, Kelly said, Littauer is the main provider of care in Fulton County, and the town of Broadalbin lacks a medical provider. Finding a site took about six months, he said. The hospital settled on 249-256 Route 29, a vacant piece of land at the intersection of Eagle Mills Road, not far from the Galway border. Engineering tests showed the soil suitable for a septic system, and test drilling showed a well would be viable. The site is good for present and future needs, Kelly said. "It's got the potential for growth; we think it will grow in the next 10 years," he said. "Also, we don't have anything in the town of Broadalbin and patients have been asking."

The facility would be operated by a physician and a nurse practitioner or physician assistant, plus support staff. It would be large enough that additional medical providers could be added if needed in the future. It would provide primary, prenatal and pediatric care; specialty care including urology, neurology and gastroenterology would be available on a rotating part-time basis. It would also be a regional specimen collection center and would provide retail pharmacy service delivery, due to limited pharmacy options in the area. It would be a continued expansion of Littauer's model of putting basic and preventive medical care in the communities where people live, so they will be able to use it more easily. Those patients are then referred to the main hospital in Gloversville for more advanced or specialized care.

Kelly said the model is working well for patients because they can develop relationships with a single primary care doctor who will monitor and treat long-term poor-health predictors such as high blood pressure and high blood cholesterol. "That's really good medicine — to keep people as healthy as possible," he said. It's also good for the hospital, which Kelly said has possibly the strongest financial performance of any small rural hospital in New York state. In surrounding metropolitan areas, such as Utica, Glens Falls and Albany, large physician groups provide primary care and refer the specialty care to themselves, he said.

"We do both; we do the primary care, and our physicians refer to us," Kelly said. "It's been a pretty successful model." Littauer's inpatient admissions increased 21 percent in 2017 over 2016, he added.
